DEPOSITS

A puppy can be reserved and held with a minimum deposit of \$_____. The deposit is non-refundable and non-transferable if the buyer defaults on the purchase of the puppy. Spruce Hollow Bullies will refund the full deposit only if puppy cannot be sold due to serious illness or death.

To hold a puppy, buyer agrees to send an overnight priority Postal Money Order or make a Direct Bank Transfer in the minimum amount of \$_____ within 72 hours. Puppy will be placed on a HOLD while awaiting the deposit. Once the deposit is received, said puppy will be marked and considered SOLD. If deposit is not received within 72 hours, puppy will be placed back up for sale. A signed and dated copy of this Contract / Guarantee must accompany the deposit within 72 hours or puppy will be put back up for sale.

PAYMENT

Full payment of the puppy or the remaining balance must be paid when the puppy reaches eight (8) weeks of age or before delivery, whichever comes first. Final payment must be a Postal Money Order or a Direct Bank Transfer. Puppy will not be shipped until full payment is received.

SHIPPING

If buyer is unable to pick up their puppy in person, the puppy may be flown, at the cost of the buyer, to a nearby airport anywhere in the continental USA or CANADA pending airline restrictions and seller's conditions.

GUARANTEE

Spruce Hollow Bullies guarantees bulldog puppy to be in good health, to the best of our knowledge, and has been examined by a veterinarian before leaving our home. For this Health Guarantee to become effective, puppy must receive a complete health physical by a licensed veterinarian within 72 hours of delivery to buyer. Failure to do so voids the Health Guarantee. If the veterinarian finds said puppy to have a life threatening condition, buyer must inform SPRUCE HOLLOW BULLIES the same day as diagnosis. SPRUCE HOLLOW BULLIES will replace the puppy with another of the same sex and quality as soon as a comparable puppy becomes available. The buyer has five days upon discovery of a life threatening condition to return puppy and registration to the seller. Failure to return the puppy to seller within stated time frame is construed to reflect that the buyer is satisfied with the puppy's health and absolves the seller from any and all responsibility.

All transportation expenses related to the original puppy as well as the replacement puppy is the responsibility of the buyer.

SPRUCE HOLLOW BULLIES guarantees puppy to be free of any genetic / hereditary defects that cause death or serious impairment of vital function in said puppy until one year of age.

Although a conscious effort is made by SPRUCE HOLLOW BULLIES to breed and produce sound, healthy bulldogs, buyer is aware and understands that due to the nature of this breed, bulldogs are predisposed to certain breed specific issues including cherry eyes, stenotic nares, entropion / ectropion, loose hips, skin allergies and other common bulldog breed ailments. This Guarantee excludes any breed specific issues that are considered normal or common for the bulldog breed.

We do not breed dogs with undesirable conditions such as mange or bad hips, but we cannot guarantee that previous generations did not have these conditions in their lines. Therefore, we cannot guarantee these conditions will not show up unbeknownst to us in future litters. It is also very important to have a veterinarian knowledgeable about the bulldog breed.

At the time of purchase, puppy will be current on all worming's and vaccinations according to age. Buyer agrees to keep all vaccinations and worming's current, including rabies, and to provide regular heartworm preventative as prescribed by a veterinarian. Buyer also agrees to keep puppy / dog in humane conditions, providing proper food, water and shelter. This Guarantee will be completely null and void if said puppy / dog is used for any sort of illegal activity (i.e. dog fighting) or in any extreme sports (i.e. weight pulling), or is mistreated, abused or not taken care of.

RIGHT OF RECOVERY / REPLACEMENT

In the event the buyer is unable to keep this dog for any reason, the buyer agrees to offer to the seller the first chance to take said puppy / dog back. The buyer will not abandon the dog to a shelter. Buyer agrees not to sell this dog to any broker or pet store or puppy mill.

If the buyer is to sell said puppy / dog to someone, the buyer is to notify the breeder of the new address during the dog's lifetime.

FULL CKC / LIMITED CKC

If the puppy is sold with limited CKC (as a pet only), the said puppy must be spayed / neutered by the age of one (1) year.

Any puppy being sold with a full CKC (breeding rights) is not guaranteed in any way shape or form to produce puppies. The English Bulldog breed is a difficult breed to reproduce and comes with many risks. A puppy being sold with breeding rights does not mean that it will successfully reproduce.

This is a legal and binding document. Any disputes resulting from this contract are to be settled in the laws of New Brunswick, Canada.
